Implementation of UGC Guidelines on Public Self-Disclosure

In accordance with the directives issued by the University Grants Commission (UGC), all Higher Education Institutions and Universities in India are required to implement the UGC Guidelines on Public Self-Disclosure.

These guidelines emphasize transparency and accountability by mandating institutions to publicly disclose key information relating to their functioning, governance, academic performance, financial details, and other relevant aspects on their official websites and notice boards.

Key Points Include:

- Disclosure of institutional vision, mission, and governance structure
- Information on academic programs, courses offered, and faculty details
- Admission policies and processes
- Details of student enrollment, examination results, and progression
- Financial statements and audited accounts
- Policies related to grievance redressal, anti-ragging measures, and code of conduct

All departments and concerned officials are directed to ensure timely and accurate uploading of this information on CGC University, Mohali website as per UGC's prescribed format and timelines.

This initiative aims to enhance transparency, facilitate informed decision-making by stakeholders, and uphold the integrity of CGC University, Mohali.

UGC has circulated guidelines on Public Self-Disclosure by Higher Education Institutions, 2024, dated 10.06.2024. As per the Guidelines, all Higher Education Institutions are required to maintain a functional website to provide relevant information to stakeholders. The information disclosed on the website should be easily accessible to everyone, on the home page, without any need for registration or login. Additionally, there should be a 'search' facility available for easy navigation.

Also, the Universities were directed to submit detailed information for inspection purposes under Section 13 of the UGC Act, 1956 (soft copy only in the prescribed format available at the UGC website at the link <https://www.ugc.gov.in/oldpdf/proformaprivateuniversities.pdf>) along with supporting documents duly attested by the Registrar of the University within the stipulated period. The Universities were also directed to upload the filled-in format and appendices on their website by giving a link on the home page so that the information is accessible to the students and the general public.

The above was followed by several reminders through e-mails and online meetings.



Guidelines on Public Self-Disclosure by Higher Education Institutions

National Education Policy (NEP) 2020 emphasizes transparent self-disclosure by Higher Education Institutions (HEIs). Public self-disclosure by HEIs, in fact, is one of the fundamental principles of the policy. NEP contemplates that HEIs shall be responsible and accountable to the stakeholders through transparent self-disclosure of all relevant records.

2. The availability of information in the public domain is an important source of accountability.
3. Stakeholders in the higher education system such as students, parents, research scholars, prospective students, regulatory bodies, accreditation agencies, alumni, and the public desire to seek information from the websites of HEIs.
4. Every Higher Education Institution shall maintain a functional website for making relevant self-disclosure to the stakeholders. The disclosure made on the website shall have unrestricted access without any requirement of log-in/registration and shall have a 'Search' facility for easy access.
5. Higher Education Institutions may provide information related to the following on their websites and provide the links, wherever possible:

- Recognition / Approval (2(f), 12B, etc. as applicable)
- Annual Reports
- Annual Accounts including Balance Sheet, Income and Expenditure Account, Receipts and Payments Account along with Audit Report
